- Operation of Bear Emergency Teams, use of Karelian Dogs, bear-proof garbage containers, and other measures to prevent habituation of Brown Bears to human activities and settlements.
- Livestock Guarding Dogs, electric fences, and other damage prevention measures.
- Anti-Poison Dog Units to prevent the poisoning of wildlife or other animals.
- Other actions, implemented in the framework of the LIFE ARCPROM project.
